# **New Tool Added to Sidney Economic Development Toolbox**

The City of Sidney recently added one more tool to its economic development toolbox. City Council adopted a new water rebate program for businesses defined as high volume water users. Any existing business that annually uses over 100,000 ccf or new businesses that will use over 100,000 ccf are eligible for the program.

Other attractive business incentives include enterprise zones which grant real property tax abatement for manufacturing, warehousing and R & D facilities that agree to retain or create employment and establish, expand, renovate or occupy a facility. Residential, commercial or industrial projects occurring in community reinvestment areas (CRA) may be eligible for real property tax abatement. The city has a few Tax Increment Financing (TIF) districts established to finance public infrastructure improvements and, in certain circumstances, residential rehabilitation.

The Revolving Loan Fund provides gap financing for local business development. The goal of the program is to create and retain permanent, private-sector job opportunities, through the expansion and retention of business and industry.

The Downtown Rehab program provides up to a \$30,000 matching forgivable loan for downtown property owners making façade improvements or alleviating interior code violations in the nine block downtown area.

Municipal job creation and/or job retention tax credit programs are also available to grant nonrefundable tax credits against a company's Sidney income tax liability on its business profits.

Other creative programs are also available in partnership with the Dayton Development Coalition, JobsOhio, Dayton Port Authority and other entities to help businesses make the decision to stay or locate in Sidney.

### **Mike Dodds Retires from Executive Director Position with SSEP**

After a successful career working in Shelby County, long-time Executive Director of Sidney-Shelby Economic Partnership, Mike Dodds, has officially retired from SSEP. On May 11th he enjoyed the company, accolades, and best wishes from family, friends, public officials, and business associates at a Business After Hours Celebration at The Oaks in Sidney.

Dodds thanked his colleagues in his remarks and said, "It is not one person, but a group of people willing to step out, take some risks, and make some decisions, that have helped Shelby County's economy grow. They've challenged me, they've challenged themselves, and I think the growth and development we have experienced is because of the long-time commitment of the Board."

## **STAR House Opening in 2019**

A groundbreaking celebration was recently held for the STAR Transitional Treatment House to be built next to the Shelby County Jail located at 597 Gearhart Road in Sidney. The STAR House will fill the gap between incarceration and complete independence for those in recovery from drug or alcohol

addiction. While living in the STAR house, men will participate in counseling, have outside employment, be enrolled in Medication Assisted Treatment which will curb drug cravings, and learn life skills

such as cooking and budgeting. The 4,269 sq. ft. facility will house 20 male residents. It will be operated cooperatively by The Shelby County Sheriff's Office, Tri County Board of Mental Health and The Shelby County Commissioners with additional funds from community partners including Shelby County United Way.

The bid has been awarded to Westerheide Construction Company with an estimated cost of \$1,004,200.

Tri-County Board of Mental Health and Ohio Mental Health and Addiction Services has each committed \$400,000 for the construction with the State of Ohio awarding Shelby County additional funds through the 2018 Capital Budget. The Shelby County Commissioners have committed ground for the site and are extending sewer lines to the property to facilitate timely construction.

Sheriff John Lenhart stated, "The STAR House will benefit offenders by giving those released from jail a safe place to live while maintaining sobriety. Our goal is to show the community that we care about people with addiction who want to make positive changes in their lives. The opiate epidemic has already taken too many..."
